Услов: Basic knowledge of macroeconomic theory as well as of European policy and politics issues.

Циљ предмета:

The general objective of the course is to provide a thorough training in the European regulatory framework about monetary policy and financial services. We intend to stimulate the critical use of scientific analyses required for future positions in the financial sector as academics, economists, financial analysts, or other.

Исход предмета:

This course seeks to provide students with an in-depth understanding of the institutional and legal underpinnings of the European financial sector's regulatory framework.

Садржај предмета:

Central banking and monetary policy in EMU; European banking law and regulation;

European securities law and regulation; European architecture of regulation, supervision and financial stability. In the first part the course covers the structure and function of the European System of Central Banks as well as European Central Bank's policies and activities.

We identify the instruments of monetary policy available to influence the money market and determine interest rates and examine policy decision making. In addition to examining the EC Treaty provisions on central banking, monetary policy, freedom of movement of financial service providers, in the second part emphasis is being put on the secondary Community legislation in the fields of banking and capital markets in the context of the European financial integration process.

The course will involve a comprehensive analysis of the current situation of banking and capital markets supervision (Basel II, MiFID, SEPA etc). Finally the issues with regard to the European financial architecture are addressed separately.
